LEAGUE BOARD MEETING MINUTES

MAY 16, 2007

CALL TO ORDER

The meeting was called to order by President Mike Hester at 8:30 A.M. in the Roundup room, men's club, Sun City West.

Rich also reported that the National League will have their team selection meeting on October 9, and the National League managers meeting will be 1:00 P.M. at the Men's Club, roundup room October 11th.
