General Terms & Conditions

The term of this reciprocal agreement is valid from the initial date signed below through the end of the current year only. Violation of the terms of this agreement or any RCSC rules and regulations may result in cancellation of the agreement without notice. Any portion of this agreement may be modified, amended or canceled by agreement of all parties, as signed below, upon a 30 day written notice.

The following conditions provided are for guidance and adherence by RCSC Chartered Club members ("club members") and visiting reciprocal club members ("visiting members"):

1. Reciprocal privileges are offered only to like clubs with like facilities.
2. Use of reciprocal club facilities must be equal to use of RCSC facilities.
3. Visiting members shall not displace club members.
4. Visiting members must produce a valid reciprocal club membership card and picture ID.
5. Upon arrival at the reciprocal club, the visiting member shall present the above-said documents for registration purposes before using the reciprocal club's facilities.
6. Visiting members may only use reciprocal club's facilities during reserved club hours.
7. Visiting members are not allowed to bring participating guests.
8. Visiting members shall abide by the rules and regulations of the club members.
9. Reciprocal clubs have the right to bar certain visiting members from using their facilities with and without assigning any reason, so long as a majority of the Club's Executive Board approve of such action.
10. This agreement supersedes any previous agreements or reciprocal arrangements made.
