

Bylaw amendments for the April 2026 General Meeting of SCW Softball

Art I Section B Purpose of Organization: Delete in full and replace with:

The Sun City West Softball Club purpose is to promote interest in the sport of slow pitch softball; to provide the opportunity for all members to learn and improve their play; to schedule play, practices and tournaments; to sustain a high level of fellowship, sportsmanship and friendly competition; to help in the establishment of rules of play, field etiquette and behavior; to promote social activities associated with softball as part of our community and to provide support to other organizations in Sun City West.

Art II Section H Maintaining a Chartered Club: Delete the following: A club charter is dependent on club membership, membership participation of existing club charter.

It does not appear to make sense and may be a partial insertion.

Art IV Section A Club Officers: Add the following: At all times, there shall be at least one (1) member from each major league (American, Central and National) on the board of directors. Elections shall be structured to accommodate this provision.

Art IV Section B Club Officer Election: Delete first sentence and replace with the following:

The Club Board shall be elected by a majority of those voting at the Club's annual membership meeting, at the times and locations authorized, or electronically, after a quorum is established.

Art IV Section E...Term Lengths: Delete the second paragraph and replace with the following:

Terms of office for the Board is two (2) years and terms of office for the four (4) officers is one (1) year from January 1 through December 31 of each year. Board members may not be reelected until they have been off the Board for at least one (1) year.

Art V Meetings Section B Club Business: Delete the word “Personal” and replace with “Personnel”.

Art V Meetings Section C Minutes: Delete the second paragraph and replace with the following:

General Meeting Minutes and Board Minutes should be available to Club membership prior to the subsequent meeting.

Art V Meetings Section F Special Meetings: Delete third paragraph and replace with the following:

Any Board member may call for a special meeting of the Board.

Art VI Financial Section B Spending Limits: Delete the wording : However, in an emergency situation

Art VII Committees Section A Non Permanent Committees: Add the following: The Club Board will appoint all committee chairs and have approval of all committee members at its discretion.

Art VII Committees Section B Permanent Committees: Add the following: Appointments to any committee will be per Section A herein.

Art VII Committees Section F Other Committees and Their Duties: Delete the entire section and replace with the following: Due to ever changing requirements of the Softball Club this section will be documented in SCW Softball Club Policy Documents as “Softball Club Other Committees/Coordinators and their Duties”. All chairs and members will be appointed or approved by a majority vote of the Club Board as well as the rotation schedules for each committee membership and the assigned duties.
